**B. QUERIES RAISED DURING THE PRE-BID CONFERENCE:**

<b>Queries</b>	<b>Clarification/s</b>
1. How do we go about the misspelled titles and authors, or lacking words in the titles found in the Bid Notice and Annexes?	<p>A supplemental bid bulletin will be issued to correct all misspelled titles and authors as well as other concerns such as lacking words and incorrect ISBN.</p> <p>Note that salutations such as Rev., Dr., Atty., Ph.D. of the authors were</p>

	not included in the technical specifications. Therefore, this will not be a ground to determine whether the bids are compliant/non-compliant.
2. If we are the publisher, do we need to provide an authority to sell?	The bidders don't have to provide authority to sell for the books they published. They only need to provide documents that are applicable to them.
3. Do we need to certify photocopy of documents we will submit?	Yes. Documents should be certified as true copy of the original record on file.
4. Do we need to ring bind and tab the documents before submitting?	There is no prescribed binding for the documents to be submitted.  The bidders may opt to have the documents bound. The BAC recommends to place tabs on the document for ease of reference.
5. Is there a prescribed format in naming and sealing the bid envelope?	There is no prescribed for labelling the bid envelop. The bidders may refer to the sample labelling of envelopes found in <i>Reminders</i> .  To seal the bid envelop, kindly glue the seal flap, sign the flaps, and place an adhesive tape over the flap.
6. How many hard copies should we provide?	Only one (1) copy is required.
7. If a publisher would like to bid for 2 or more lots, how many bidding documents should be purchased?	Only one (1) bidding document should be purchased.
8. Is the SLCC considered for this bidding limited to government transactions only?	The SLCC for this bidding considers transactions made both with government and private institutions.
9. Do you have a prescribed paper size for our submissions?	For notarized documents, legal-sized paper is encouraged.  For the rest of the documents, A4 or letter-sized paper will do.

<p>10. For areas under ECQ or heightened community restrictions, how do we go about the notarization of documents?</p>	<p>In observance of the requirements of RA 9184 or the Government Procurement Reform Act, bid documents shall be accompanied by notarized Bid Securing Declaration, <i>as applicable</i> (Annex D) and Omnibus Sworn Statement (Annex E).</p>
<p>11. For the NFCC, what is the value of the multiplier (K) to be followed for the computation?</p>	<p>Based on section 23.4.1.4 of the 2016 Revised IRR of RA 9184, the value is set at 15 as shown below:</p> <p>“NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under ongoing contracts, including awarded contracts yet to be started, coinciding with the contract to be bid.”</p>
<p>12. If I send my bid documents via courier prior to the deadline but reached your office after the deadline, will my bid still be accepted?</p>	<p>Yes. The bid documents are still considered valid if sent via courier on or before 23 August 2021.</p> <p>There will be a separate bid opening for documents received at the office after the first opening of bids (24 August 2021). Concerned bidders will be notified properly.</p>

- d. NBDB adheres to the “No-Contact Rule.” All clarifications shall be made in writing, in the form of email and/or formal letter addressed to the Procurement Officer.
- e. Dates, in the absence of any qualifications, are meant to be calendar days. Calendar days include Saturdays, Sundays and Holidays.
- f. The deadline for the submission of bids is on 23 August 2021 at 5:00 PM at the NBDB Office located at the 3/F and 4/F Regalado Hive Building, Regalado Avenue, Fairview, Quezon City. The internet time, set at GMT+8, shall be used as a reference in determining the time for the submission of bids. Hence, participating bidders are advised to synchronize their timepieces with the internet time GMT+8.

Bidders are encouraged to submit their bid documents days ahead of the deadline.

- g. Bid opening shall be at 9:00 AM on 24 August 2021 at the NBDB Office located at the 3/F and 4/F Regalado Hive Building, Regalado Avenue, Fairview, Quezon City and via Video Conferencing through Zoom. Bids will be opened in the presence of the Bidders. Although the bidders’ attendance during the Opening of Bids is not compulsory, it is advised that bidders send their representative.

IATF COVID-19 protocols shall be strictly enforced. Those participating in-person shall be required to wear face mask and face shield at all times. Likewise, they shall be required to undergo COVID-19 antigen test on site. Anyone with positive result shall be barred from the in-person bid opening.

- h. Each and every page of the Price Schedule (Annex A) and Bid Form (Annex G) must be appropriately signed by the bidder or the bidder’s authorized representative.
- i. All licenses, permits, and other required clearances should be valid at the time of the submission of bids, post-qualification evaluation, signing of the contract, delivery of goods, and release of payments.
- j. The following documents are required to be notarized, which should be duly sworn to and include complete information on the PTR No., MCLE No., Authority or Commission Number, etc. of the Notary Public:
  - 1. Bid Securing Declaration, as applicable (Annex D)
  - 2. Omnibus Sworn Statement (Annex E)
- k. NBDB reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

All provisions, conditions and statements in the bidding documents inconsistent with this Bid Bulletin are either modified or rendered ineffective, as the case may be.
