**B. QUERIES RAISED DURING THE PRE-BID CONFERENCE:**

Queries	Clarification/s
1. The stocks of some titles are not available or does not meet the requested number of copies as per the PR.	We'll discuss further regarding the question and get back to you on 30 May 2022.
2. What if they will be bidding for two lots? Do we need to submit bid docs for two lots?	You have to submit a complete set of documents for each lot. Because each lot is considered as one bid.
3. We missed some details in the requirements for the bidding, where can we ask for the details?	Sir Edcel Bober will be sending an email regarding the requirements for the first and second envelope.
4. Can a publisher still join if no SLCC yet?	Yes, in the form that's given, just indicate that SLCC isn't available yet.
5. Clarification, for the legal requirements, since we cannot get all the original copies, can we send photocopies?	Yes, but we will be needing a Certified True Copy by the administration department of your office.
6. Can a publisher add new titles of books from the lot?	No, we cannot add new titles as the Technical Specifications is final.
7. One of the requirements is Tax Clearance, then June 7 is the submission, our certification will expire on June 8. Do we need to submit a new updated one?	For prequalification documents, the past certification will suffice. But for the post qualifications, we will be needing an updated one.
8. We still haven't received the 2022 certificate. Can we send the 2021?	Yes, but please furnish us a copy of your email communication with the registration division from NBDB.
9. Do we need to pay for another bid docs if we're bidding for another lot?	No, you just have to pay for one bid document for this ITB.
10. Regarding the payment for the bid docs, can we still pay through GCash?	This year, the bid docs should be paid in the NBDB office.
11. When is the delivery of books?	The delivery of books shall be made 7 calendar days after the release of Notice to Proceed.
12. Do you have any specifications on the labels of the packages for book delivery?	It is indicated in the ITB and the Pre-bid conference presentation.

- d. NBDB adheres to the "No-Contact Rule." All clarifications shall be made in writing, in the form of email and/or formal letter addressed to the Procurement Officer.
- e. Dates, in the absence of any qualifications, are meant to be calendar days. Calendar days include Saturdays, Sundays and Holidays.
- f. The deadline for the submission of bids is on 6 June 2022 at 11:00 am at the NBDB Office located at the 3/F and 4/F Regalado Hive Building, Regalado Avenue, Fairview, Quezon City. The internet time, set at GMT+8, shall be used as a reference in determining the time for the submission of bids. Hence, participating bidders are advised to synchronize their timepieces with the internet time GMT+8.

Bidders are encouraged to submit their bid documents days ahead of the deadline.

- g. Bid opening shall be at 10:00 AM on 7 June 2022 at the NBDB Office located at the 3/F and 4/F Regalado Hive Building, Regalado Avenue, Fairview, Quezon City and via Video Conferencing through Zoom. Bids will be opened in the presence of the Bidders. Although the bidders' attendance during the Opening of Bids is not compulsory, it is advised that bidders send their representative.

IATF COVID-19 protocols shall be strictly enforced. Those participating in-person shall be required to wear face mask and face shield at all times. Likewise, they shall be required to undergo COVID-19 antigen test on site. Anyone with positive result shall be barred from the in-person bid opening.


- h. Each and every page of the Price Schedule (Annex A) and Bid Form (Annex G) must be appropriately signed by the bidder or the bidder's authorized representative.
